I. Call to Order

II. Review of Council Charge

Reviewed Committee charge - planning and policy-making for student affairs division. What is the policy? What is the procedure? What is the rule?

Scope of Responsibility: The SAC shall:

- Oversee Student Affairs policy, procedure, and guideline development.
- Develop, implement, and evaluate student support services including processes for: recruitment, pre-enrollment, admission, career interest, orientation, placement testing, advisement/registration, financial aid and internal scholarships, supplemental education support, student engagement, retention support, student judicial, student life/co-curricular, student mental and physical health/wellness, student assistance with fundamental needs (e.g. housing, transportation, food, etc.), athletics, graduation functions, certification exams, and career services.
- Review and recommend policies and procedures for Student Affairs areas.
- Implement strategic plan initiatives assigned to the Vice President of Student Affairs (VPSA).
- Develop and review the Student Affairs Board Monitoring Report.
- Review of the efficacy of persistence and completion efforts as they evolve collegewide.
- Review academic policies and procedures as they pertain to student services.
- Evaluate academic and student support initiatives across the College.
- Serve as a communication conduit to the College.
- Assist in maintaining accreditation requirements for HLC.



- Develop or suspend committees, as needed, through use of ad-hoc groups to research, analyze, and make recommendations.

Policy Responsibility: Student Affairs (A31xx, A32xx, A33xx, A34xx).

III. Election of Council Chair

Cara volunteered to chair and was approved by committee vote.

IV. Policy Disposition Document
