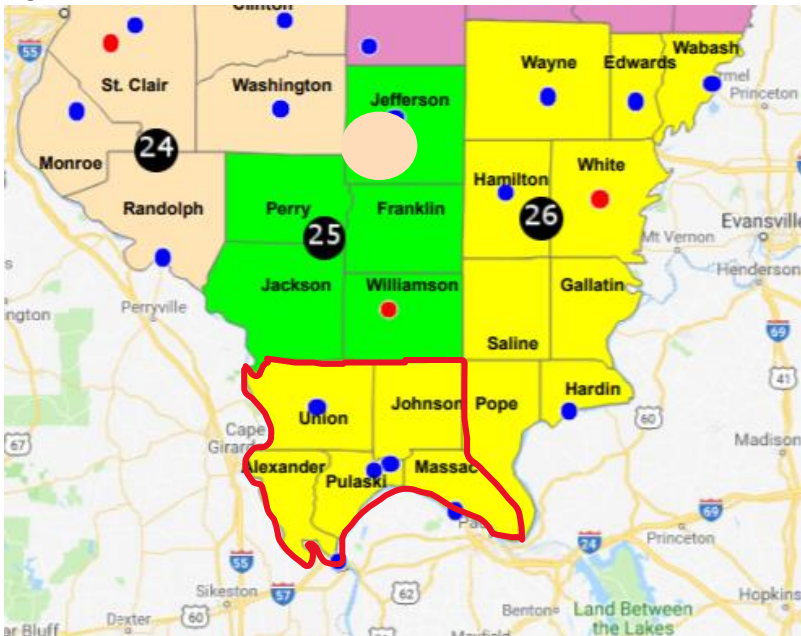

Introduction

The following report provides an analysis of the labor market in the Shawnee Community College service area, outlined in red in Figure 1, and its surrounding regions. This report relies on data for 2018-2028 obtained from the [Illinois Department of Labor](#) for the Illinois Local Workforce Innovation Areas (LWIA) 25 and 26 (Figure 1), [Missouri Economic Research & Information Center](#) for southeast Missouri, and [Kentucky Center for Statistics](#) for western Kentucky.

According to Board Policy *B1000 College Purpose*, Shawnee Community College's purpose is to provide high quality and affordable higher education services to its service area, which advance individual economic mobility, personal growth, and the local economy. Determining occupational and workforce training needs within the SCC service area is a critical step in reviewing our existing programs and developing new programs that will meet the needs of the community while also providing a living wage to its citizens.



Method

Step One: Occupational and wage reports for the years of 2018-2028 were obtained from the aforementioned governmental websites for Illinois, Kentucky, and Missouri. The Illinois data was downloaded by Local Workforce Innovation Areas (LWIA), and areas 25 and 26 are included in this analysis. As can be seen in [Figure 1](#), the SCC service area falls within LWIA 26, with its northernmost border along LWIA 25. The Kentucky and Missouri reports were downloaded by region. Due to SCC's proximity to these border states, western Kentucky and southeast Missouri were included in this analysis.

Step Two: For this report, occupations of high need are considered any occupation with 10 or more projected total annual openings between 2018 and 2028. Once these occupations were determined for each of the four regions, they were narrowed to those that provide a projected minimum living wage for at least 1 adult with 0 children in the SCC service counties of Alexander, Johnson, Massac, Pulaski, and Union in Illinois (Table 1).

The lowest minimum living wage of \$12.76 an hour (Johnson and Union) was used in this report, which translates to an approximate entry salary of \$26,600 annually.

[Tables 2 through 9](#) display the high need, living wage occupations projected for each region in two ways; by need, to illustrate the highest need occupations in descending order, and alphabetically to assist with quickly searching an occupation by name. For the sake of this report, only those occupations for which both projected need and projected entry wage were provided are included, as both are essential to determine high need and living wage.

Step Three: The high need, living wage occupations in each region were compared to determine which occupations are of most need.



[Table 10](#) lists the high need, living wage occupations, in order of Standard Occupational Classification (SOC) code, projected in all 4 regions; thus, highlighting those living wage occupations projected as highest need. All SOC codes aligned to a current SCC program are marked with a plus (+).

[Table 11](#) lists the high need, living wage occupations, in order of SOC code, projected in only 3 regions. If LWIA 26, in which the SCC service area is located, is one of the 3 regions for a particular occupation, the occupation is marked with an asterisk (*).

Both tables include the typical education and on-the-job training required for each occupation as provided by the Kentucky Center for Statistics which was cross-referenced through [o*net online](#). This information is useful for community colleges when considering new programs, partnerships with labor groups, and transfer agreements with four-year institutions of higher education. This information is useful for students in determining what level of education is required before they begin their education.

Step Four: The SOC categories of all high need, living wage occupations in the 4 regions researched were sorted by SOC category. To give a snapshot of the occupation categories of highest needs, [Table 12](#) lists the number of projected high need, living wage occupations by SOC category in two or more regions and includes the typical education and on-the-job training required for the occupations in that category as provided by the Kentucky Center for Statistics. This table is useful when determining which types of occupations are projected to be of most need the SCC service area and surrounding regions to give SCC a starting point when considering new programs.

Step Five: The SCC program Classification of Instructional Programs (CIP) codes were cross walked with the SOC codes for which they align using the [education crosswalk](#) tool provided by o*net. [Table 13](#) is an alignment of all SCC programs' SOC codes and the high need, living wage occupations in the 4 regions researched to illustrate which of the current SCC programs are positioned to meet the projected occupation demands. An asterisk (*) denotes any occupation code designated as a national [Bright Outlook Occupation](#) by o*net. This designation can mean the occupation is expected to grow rapidly in the next several years, has a large number of job openings, or is a new and emerging occupation.

Next Steps: It is recommended that SCC obtain a list of major employers in each of the service area counties to survey their current and projected employment and workforce training needs, including anticipated entry wage, required and preferred education, on-the-job training expectations, and certifications/licenses, as well their willingness to serve on an advisory council to review current programs and develop new programs.
