I. Call to Order

a. Survey for Financial Aid Policy 8152. Discussion?

• When Dr. Teske and Danielle reviewed the current SAP policy 8152, they found that it was a simple SAP statement but policy 8153 was actually the procedures and processes for SAP.



- Financial Aid has recently been under a federal audit and the auditors offered up the verbiage to use to update our policy and put us back in compliance with federal regulations.
- Dr. Teske stated that she took the first two paragraphs from the document the auditors provided to submit as policy 8152 and the rest of the document is actually the procedures and processes for this policy. She went on to explain that the first two paragraphs are exactly as we have in our current document. The updates from the auditors were in the procedures and processes.
- Dr. Teske went on to say that the updated policy 8152 and its procedures and processes will ultimately replace our old policies 8152 and 8153.
- The team agreed that Financial Aid Policy 8152 and its procedures and processes as presented by Dr. Teske is ready to be submitted to the Student Affairs Council for approval. Once approved, it will move on to the Executive Council for final approval. Dr. Teske noted that this language is already on our website because the federal auditors said we had to update the language as soon as possible to comply.
