    - i. Course change: PHB 0120-Basic Phlebotomy will go from 2 to 1 lecture hours, and from 0 to 2 lab hours with CIP Code of 511009. (JoElla Basler made a motion; Lori Armstrong seconded – motion carried)

**Addendum to Minutes: A change will be made to PHB 0120-Basic Phlebotomy to attach it to the PN 2127 (Practical Nursing) curriculum since it is in a similar field and will be removed from the GSD 0800 (General Ed) curriculum.**
    - iii. Course change: STP 0123-Surgical Procedures I will go from 3 credit hours to 1.5 credit hours with lecture hours going from 2 to 1, and lab

- iv. Program change: Surgical Technology (ORT 5200) will be decreased in credit hours from 62.5 hours to 61 hours. (Lori Armstrong made a motion; Ruth Smith seconded – motion carried)

**Addendum to Minutes: After the September 15 C&I meeting, it was discovered there were discrepancies with STP 0123 and STP 0125 in the ICCB Course and Curriculum Master Lists, affecting the recently approved course and program changes in items iii and iv above.** The table below describes the credit hours listed with ICCB, as well as the current catalog hours and the recent request to change STP 0123. The request to change from 5 to 3, and 2.5 respectively, was made in (approximately) November 2020 when the program changed from a certificate to an AAS. Changes, however, were not made with ICCB at that time, although the catalog went on to reflect the changes that were made at C&I. The Summer 2021 cohort would have had inaccurate credit hours and been charged inaccurately (or provided financial aid) because it would have been off by 4.5 credit hours. Current hours in the catalog are listed as 62.5, which actually aligns with the ICCB Master. ICCB will advise how to best rectify this situation.
