## **Facility Master Plan**

Following the completion of the Facility Condition Assessment conducted by Gordian, as approved by the Board on August 1, 2022, the Facilities staff has been diligently integrating the assessment results into the development of the Facilities Master Plan. This comprehensive planning process is currently being led by architects from Cordogan Clark, whose engagement was approved by the Board on March 16, 2023.

The Facility Condition Assessment provided a critical foundation for the Master Plan by offering detailed insights into the current state of the facilities portfolio. This data-driven approach enables the team to make informed decisions about system replacement timing, capital expenditure needs, and long-term facilities investment strategies.

Cordogan Clark, known for their expertise in campus master planning, is working closely with the Facilities staff to create a plan that not only addresses immediate needs identified in the assessment but also aligns with the organization's long-term vision. Their approach typically involves preserving and enhancing existing positive features while introducing new elements to revitalize the campus environment.

This collaborative effort between the Facilities staff, Gordian's assessment data, and Cordogan Clark's planning expertise is expected to result in a comprehensive Facilities Master Plan. This plan will serve as a strategic guide for future facility improvements and capital investments, ensuring efficient use of resources and alignment with organizational goals

## **Completed Projects & Initiatives**

**Fleet Vehicles** - Two additional Fleet vehicles (2025 Nissan Altima and a 2024 Chrysler Pacifica) were purchased (Board Approved December 19, 2024)

**Project 24004** - Massac County Extension Boiler System (Board Approved February 15, 2024)

**Disc Golf Course** - Additional equipment/signage has been ordered and concrete T-boxes will be poured by our HCCTP students, with a completion date in late spring.

**Illinois College Assistance Program (I-CAP) Waste Reduction Plan** - completing this plan by April 1, 2025. Pursuant to [415 ILCS 20/3.1](#), the College is required to update the Waste Reduction Plan every five years since the year 1995. Illinois Environmental Protection Agency (IEPA) has provided a document that, upon submission, will be considered a submission of an updated waste reduction plan for the year 2025.

## **Assessing Facilities**

Extension Center Campuses are undergoing continuous, comprehensive assessments as new acquisitions are made, encompassing a wide range of facility needs. This process includes evaluating:

- Medical Equipment: New purchases, such as EKG equipment for Allied Health programs, are being assessed for their specific requirements and integration into existing facilities.
- Electrical Systems: The electrical infrastructure is being evaluated to ensure it can support new equipment and meets current standards. This includes assessing main electrical services, distribution panels, wiring, and any necessary upgrades to accommodate new technology.
- Space Adequacy: Assessments are being conducted to determine if existing spaces can effectively house new equipment and support current and future program needs, such as beds/cabinets for the CNA classes beginning at the Massac County Extension Center.
- Building Systems: Comprehensive evaluations of HVAC, plumbing, and other building systems are being performed to ensure they can support new equipment and maintain optimal facility conditions.
- Technology Infrastructure: IT and technology systems are being assessed to support new equipment and ensure seamless integration with existing networks.
- Safety and Compliance: Evaluations are being conducted to ensure all new equipment and facility modifications meet current safety standards and regulatory requirements. Our Insurance Carrier, on February 27, has toured Main Campus as well.
